

What documents can be notarized online?

As per the *Notaries Act* and the *Commissioner for Taking Affidavits Act* all documents cannot be notarized online however there are a list of documents that **CAN** be notarized online indicated below.

CAN BE NOTARIZED ONLINE

- Oaths, Affidavits, Solemn Affirmations and Declarations
- Property Documents
- Service Ontario/Ministry of Finance Documents. Immigration, Refugees & Citizenship Canada Forms
- Statutory Declarations
- Passports - In Lieu of Guarantor Form
- Ontario Court Forms (including Form 35.1: Affidavit in Support of Claim for Custody or Access, Form 35.1A: Affidavit - Child Protection Information)
- OSAP Affidavits
- Insurance Claims
- Professional Accreditation
- Sworn Statement for a Family Gift of a Used Motor Vehicle and other Vehicle Ownership Transfer documents
- Last Will and Testaments
- Birth certificate corrections
- Powers of Attorney
- Consent to Travel Documents
- Invitation Letters
- Permanent Residency card applications
- Electronic Document Certification
- Fingerprints & Criminal Record Check Notarization/Certification
- Translated Documents




